





Chandipur, District – Purba Midnapore, Pin – 721625, henceforth called the **SETTLER**, (which expression shall unless, excluded by or repugnant to the context, be deemed to include his heirs, survivors, successors, administrators representatives and executors) of the **ONE PART**;

2. **SMT. SUMITA MAJHI**, daughter of Susodhar Majhi, by faith Hindu, by occupation Business, Indian National, residing at Village – Haibatpur, P.O. – Baitrokunda, P.S. – Mariydu, District – Purba Midnapore, Pin– 721401.

3. **SRI SUBIR DALAI**, son of Niranjan Kumar Dalui, by faith Hindu, by occupation Business, Indian National residing at Actarpur, Village Nanagoshpur, P.S. Bhobhanpur, District – Purba Midnapore, Pin– 721633, all the above persons henceforth are jointly called the **TRUSTEES** of the Trust Board which expression shall unless excluded by or repugnant to the subject or context be deemed to mean and include the **TRUSTEE or TRUSTEES** for the [time being of these presents and their successor or successor's in office) of the **OTHER PART**.

**WHEREAS** the Settler is desirous of establishing a Trust for Public Charitable Objects and purpose in India, hereinafter expressed and the Trustees hereinabove have at the request of the said settler agreed to act as Trustees of these presents upon the terms and conditions hereinafter contained and with these object the Settler has donated/ contributed a total sum of Rs.5,000/- (Rupees five Thousand) only.

**NOW THIS DEED OF TRUST WTTNESSETH AS FOLLOWS:-**

I. The Trust shall be known as “ARYA DEVELOPMENT & WELFARE TRUST OF INDIA”.

II. The registered office of the Trust shall be situated at Hanschura School Bazer, Muratpur, Chandipur, Purba Midnapore.

III. **OBJECTS OF TRUST:**

1. To perform that notwithstanding herein contained in the income as the corpus OF THE TRUST fund the same shall be applicable and applied to for PUBLIC

CHARITABLE PURPOSE ONLY within such territories and subject to such conditions or limitation if any as may from time to time be laid down by the Income Tax Act. 1961 or any other Acts Governing Taxation of Income the wealth of PUBLIC CHARITABLE TRUSTS so as to render the TRUST hereby established as well as its income eligible for exemption from taxation under such Act or Acts, now or prevailing or any modification replacement thereof.

2. To Act in such a way that the TRUST hereby established shall always retain the status of one such TRUST to which the provisions of section SOG(5)(VI)/35AC/35(1){II} 1G(23C)IVV/VIA and 8G/10G of the income tax Act. 1961 or any modification replacement or thereof for the time being in force shall apply so that any donation or contribution thereto is recognized as eligible for exemption or relief from tax in the hands of the donor;
3. To established (1) Jesus Nursing and Paramedical tanning Institute, (2) Astrological Research Institute, (3) Biswajatis Vidyalaya, (4) Sahid Matangini Computer Centre and(5) Arya Kinder Garden, etc for the poor and to serve to the society and to promote, start, maintain organize, run, manage, supervise, superintendent, co-ordinance, affiliate, control, guide and grant to the same and all this institute will operate and control by the Trustee.
4. To promote establish, start, maintain organize, run, manage, supervise, superintendent, co-ordinance, affiliate, control, guide and grant aid to schools, colleges, universalities, hostels, laboratories, libraries, theatres, auditorium, lecture halls, exhibition, reading training institution practical classes, and other educational institutions for the promotion of the arts, literatures, science and commerce :
5. To establish, maintain, control, manage and or render financial assistance to

hospitals, health centre nursing home, dispensaries, maternity homes, clinics, sanatorium and other establishments for providing medical facilities and to promote medical research in these centre in all faculties and systems of medical practices and provide medical help including supply of medicines providing Ambulance services, arrangement of medical van and medical unit to the public irrespective of any caste, colour and need and to promote research for medicines for cancer and other incurable diseases;

6. To start support organize and give financial and to the social, cultural and moral renaissance of the people and to develop physical, mental and educational capacity of the society and to promote schemes for such purposes;
7. To organize and undertake social welfare programs and activities to foster social unity and to reform the society through moral and ethical movements for awakening of the self in relation to the society and to organize the dedicated youth to serve the suffering humanity;
8. To establish maintain and grant, aid to institutions for the relief of the poor and advancement of education for the aforesaid purpose or purposes and to grant periodical and other occasional help to the deserving persons;
9. To do any other act for the advancement of general public utility without distinction or discrimination of sex, colour, caste, creed or religion;
10. To grant relief on the occasion of famine, earthquake, other epidemic and other occasion of calamities of similar nature and to give donations, subscriptions, or contributions to institutions, establishments or persons during relief work on such occasions;
11. To undertake traditional and experimental activities for the welfare of the

children, women, handicapped, blind persons and destitute in the social structure:

12. To establish, maintain, control, manage and give financial aid to orphanages window homes launce, asylum home for destitute and insane persons and other establishment for relief:
13. To organize held and / or arrange to held seminar, function, workshops, conferences, debates, recitations, symposiums and other cultural and literacy program and social gatherings by inviting men of eminence and scholars of outstanding national and international reputation for the same for the promotion of the aforesaid objects of the TRUST:
14. To grant scholarships, stipends, awards and prizes financial aid and assistances and other emoluments to students, research workers and to undertake any research works for the attainment of the objects of the TRUST:
15. To plan, implement and supervise development program for the uplifment of rural economy:
16. To create scope for employment by promoting small-scale, cottage and village industries in the villages and rural areas:
17. To organize self help group formation micro-credit and micro-finance training and seminar for the uplifment for the rural economy:
18. To co-operate with the Government and Non-Government organization for any development activity of the rural and urban areas:
19. To raise resource and funds from any sources as consistent with the principals and objects and in conformity with the interest of the said TRUST:
20. To co-operative and connect with national, international organizations, having

similar objectives and reputes or receive representatives from such organizations:

21. To purchase, take or loan or exchange or hire moveable and/or immovable property for fulfillment of the purpose of the TRUST:
22. To take loan from any Government Department, Non-Government Organization and Nationalized Bank to propagate the TRUST'S aims and objects for economic upliftment of the community:
23. To work for development of social welfare, health and education for the children of rural and urban area:
24. To work for development of community awareness and vocational education for the rural women:
25. To organize seminars, workshop on forum for consumer protection, environmental program, plantation, national integration etc. and to observe the birth day of National leaders with holding Mela/Exhibitions/Debates:
26. To perform work on progress of knowledge for rural people and to establish and maintain libraries, reading rooms, adult literacy classes, for educational technical, agricultural or medical knowledge:
27. To cultivate the art and culture and habit of living and working together to enhance fellow feelings activities and integrated activity:
28. To promote social, civic, moral activities to take care for orphans or of aged helpless man/woman:
29. To arrange functions, spiritual sittings, exhibitions etc, for the progress of arts, literature, science, culture etc. in the rural and urban areas:
30. To develop and improve medical activities and facilities to rural people' with providing medical support to sick, helpless handicapped people, to establish

charitable dispensary, health centre old age home etc and to develop the said Institute in the name of Jesus Nursing and Paramedical tanning Institute, Astrological Research Institute, Biswajatis Vidyalaya, Sahid Matangini Computer Centre and Arya Kinder Garden and to purchase property in the name of the said Institute.

31. To seek receive and take any subscription of gifts or donation of all kinds like money or property both moveable or immovable donated by any organization or individuals either in INDIA or abroad for any of the objects of the TRUST:
32. To help or to co-operate to individuals or associates or clubs or any other organizations, to establish and to maintain any/or all the objects of the TRUST and to help and to issue affiliation to any similar organization either in establishing or in their work progress only after getting Indemnification Bond from them and cancel their affiliation in case they engage themselves in any wrongful/illegal activity and their cancellation shall be published in Newspaper:
33. To create job opportunities for the local / zonal and other people by establishing S.S.J. Unit/Handicraft Unit Medical Sub-unit/Home Industries for the development and upgrading economy of the unemployed youth of both sexes, handicapped, orphans and other categories of people knitting, tailoring etc. and to organize training program for such developmental program, issuing Certificates after training course for the benefit of the trainees, concession, for training periods, in Govt. bus & train, only for the poor students :
34. To promote, Agri-Horticulture industries & Research Institutes for transfer of technology, to carry on business of Share Market and to carry on businesses of Net-work and business of money lending/fund realizing for the development of the poor people:

35. To promote all kind of research projects on modern science and technology, to establish rural centre for snake-biting treatment and for research work upon this subject:
36. To perform jobs relating to prevention of atrocities or cruelty on animals:
37. To work for the promotion of Yoga and Naturopathy, Astrology, Jatissastra etc
38. To establish rural museum for upkeep and preservation of age-old sculphires, work of art etc.:
39. To establish rural libraries for providing text books to the rural students living below the poverty line;
40. To organize creche, vocational homes, residential schools, family planning programme, I.C.D.S, and other Government programmes, extending schemes as the TRUST BOARD may think lift and proper:
41. To undertake housing and resettlement activities for economically or otherwise disadvantages people in rural and urban areas by way of concept formulation surveying planning supervising, producing of low cost and innovative building materials, construction financing, management, research and development and/or training:
42. To raise fund by way of loan, donations, fees etc. from any person/s, the state or central Government Organizations, Companies, corporate agencies, institutions or otherwise for the purpose of the TRUST and / or to provide funds to such beneficiaries as may be identified by the TRUST:
43. To arrange for a conservation of such parks where rare species of animals and birds breeding and bird rescue centre, shall remain and growing and take care of

them shall be done for gathering knowledge by student of school and colleges:

44. To arrange and organise Puja, Mela and Festivals for the awareness of the people in INDIA:
45. To do all welfare activities for the disabled.
46. To arrange so that this organization may take loan from banks/F.I./D.F.I./K.R.I. etc, for the following projects from time to time as under:
  - i. Renewable Energy Projects like Solar, Wind, Bio- mass / Bio-gas / Horticulture / Floriculture / Vermi-culture / Pisci-culture / Animal Husbandry / Medicinal Plants / SencuHure Projects/ paramedical project etc. in the rural areas:
  - ii. The TRUST can go for a marketing of those products;
  - iii. To take up any Water-shed management projects in the adjoining areas:
  - iv. To propagate the idea of integrated social development in all possible management,
  - v. To establish the training centre on Youth Development, Demonstration Projects, Tourism resorts in various parts of INDIA;
  - vi. It may go for micro-lending operation to operate more beneficially to the rural post destitute;
  - vii. Family planning as well as Socio-development option also shall be taken as deem fit to help the rural population in the succeeding years to come :
  - viii. To use the profits of surplus income for the developmental activities but shall not be distributed among the TRUSTEES:
  - ix. To work for all round development of SC/ST and OBC community;

**WHEREAS** THE SETTLER out of humanity and natural love to the society desirous of setting the TRUST, of handing over a sum of Rs.5,000/- (Rupees five thousand only) to the TRUSTEES with the intention than they ill hold the said sum of income arising there

from TRUST subject to the were and provisions hereinafter / herein Group declared of convening the ne which the TRUSTEES have agreed to do:

#### IV. **RULES & REGULATIONS OF THE TRUST**

1. **THAT** for effectuating the settlement, he, the settler, doth hereby transfer and assigns upto me TRUSTEES all the said sum of RS.5,000/- (Rupees Five thousand only) and hold the said sum and the income thereof in the TRUST and for the purpose hereafter declared of convening the same :
2. **THAT** for the consideration aforesaid the TRUSTEES hereby covenant with the Settler his heirs, executors and administrators that the TRUSTEES for the time being shall stand and be possessed of the said sum of Rs.5,000/-(Rupees Five thousand only) and all additions to the TRUST fund and all incomes arising thereof in the TRUST and with and subject to the powers and provisions hereinafter declared to and concerning the same :
3. **THAT** the registered / Sub-Registered project & field office of the TRUST shall be set up in time of requirement by the TRUST, any where within India and these can be transferred in any State, District, Block and Village in India for the interest of the TRUST by the decision of the TRUSTEE BOARD and the Registered Office address of the TRUST also may be shifted from time to time if the TRUSTEE BOARD decides to do so ;
4. **THAT** the TRUST shall have the bank account with any Nationalized Bank/s Foreign Banks, Private Bank, Commercial Banks or any bank/s and shall be operated by two TRUSTEES jointly as shall be decided mutually in a meeting of the TRUSTEE BOARD:
5. **THAT** THE TRUSTEES may engage themselves and carry on any business for

and on behalf of the TRUST established by this Deed and may invest any part of funds or assets of the TRUST established by this Deed and may invest any part of funds or assets of the TRUST fund in such business or Businesses for the benefit of the beneficiaries and in such case individually that TRUSTEE shall remain responsible for his wrong and loss and for this the TRUST MANAGING TRUSTEE and the SETTLER shall remain indemnified:

6. **THAT** the TRUST being established shall be irrevocable and no part to the TRUST FUND shall be in any circumstances, whatsoever, lend to or to be applied for the benefit of the SETTLER or his wife or his children and if the TRUST fails or is held to be involved for any reasons, there shall be no effect upon the TRUST in favour of the SETTLER but the assets of the TRUST shall be made over to the beneficiaries absolutely. The SETTLER shall remain indemnified all the time as he is neither a beneficiary nor a manager of the TRUST:
7. **THAT** the TRUSTEES shall maintain the true and fair accounts of the TRUST FUNDS receipts and disposed of or spent and all matters in course of management of this TRUST in respect thereof or in relation to the carrying out of the object and effects to the TRUST PROPERTY. The accounting year of the TRUST shall be accounted for i.e. from 1st April to 31st March, of each English calendar year:
8. **THAT** the number of TRUSTEES shall be not less than 3 (three) and not more than 9 (nine). If there shall be any vacancies of the office of the TRUSTEES the same shall be filled up by the surviving remaining TRUSTEE or TRUSTEES by the process of nomination in consultation with and acceptance of the SETTLER and every one of the TRUSTEE shall donate yearly Rs.1200/- in the Trust Fund which shall be kept as fixed deposit in the BANK OF THE TRUST:
9. **THAT** the TRUSTEES shall have the full power to compromise or to compound

all actions against all suits and settle all accounts relating to the TRUST PROPERTY and to do all suits and settle all accounts relating as fully and effectually as if they were absolutely entitled to the TRUST PROPERTY without being liable or answerable for any loss thereby;

10. **THAT** the receipts of the TRUST for any money, stocks, funds, shares, securities or investments paid, delivered or transferred to them in execution of the TRUST or power hereof shall effectually be released and discharged the persons paying delivering or transferring the same;
11. To accept "BENEFICIARY MEMBERS" in this TRUST from age 18 yrs. to 50 yrs. Who will subscribe/ donate in this TRUST to become such member paying at a time Rs.1,001/- which shall not be refunded back to the subscriber, subject to enhancement time to time by the TRUST BOARD;
12. To issue due receipts against receiving such subscription from a person willing to be a "BENEFICIARY MEMBER" in this TRUST;
13. To issue prospectus & application forms to such persons willing to be one BENEFICIARIES MEMBER against a charge of Rs.100/- (receipts to be issued) to each applicant, subject to enhancement/change from time to time by TRUST BOARD;
14. To arrange for training of all such Beneficiary Members in subject/courses as per their need, choice and aptitude subject to the availability of that said course under this TRUST BOARD;
15. To help such BENEFICIARY MEMBERS after their training course is completed, they obtain their own Group -Income — Generating Project (GICP)

business by arranging loan or sponsorship for each group, against which each BENEFICIARY MEMBERS group shall give undertaking in writing by an Affidavit that while making profit from their project each member of each such group must contribute voluntarily non-refundable donation of 10% of each members profit to the TRUST FUND;

16. **THAT** the TRUSTEES jointly shall be responsible for such money, stock, shares, fund and securities as they shall actually receive notwithstanding their respectively signing receipt jointly with others for the sake of conformity and shall be answerable and accountable for the account, receipts/ neglects and any banker, broker or other person or persons /with whom or whose hands any TRUST moneys or securities may come or be deposited or given or for insufficiency of deficiency of any , stocks, shares, funds or others securities nor for any other loss unless the same shall happen through their default or negligence respectively;
17. **THAT** the TRUSTEES shall reimburse and pay and discharge out of the TRUST FUND all expenses incurred in course of the execution and administration of the TRUSTEES and in uses or for currying out their duties under these presents but they shall not be entitled to any honorarium or salary for the TRUST;
18. **THAT** TAPAN KUMAR JANA shall be MANAGING TRUSTEE of this TRUST, having the general control and supervision of the TRUST and the MANAGING TRUSTEE shall manage the TRUST FUND and carry on all the affairs of the TRUST and shall in managing the TRUST in need, shall always consult with the SETTLER;
19. **THAT** in case of difference of opinion among the TRUSTEES decision of the

majority TRUSTEE as the case may be, shall prevail and by every three months meeting of the BOARD OF TRUSTEE shall be held and evaluation of the works of each member of the BOARD OF TRUSTEE shall be made in the annual meeting of the BOARD and in that meeting in effective member of the BOARD shall be expelled in proper system:

20. **THAT** any of the TRUSTEE may delegate in witting all or any of his or her powers under these presents to his or her CO-TRUSTEE as nominee who will be entitled to exercise power or powers, in the same manner as the TRUSTEE himself could do personally not withstanding anything herein contained the TRUSTEE shall be entitled to use the name of the TRUST in connection with any matter relating to the said TRUST and for the purposes the said MANAGING TRUSTEE for the TRUST shall appoint, dismiss and reappoint any staff, manager, lawyer, advisor, advocate, auditor and substitutes and pay their expenses and fees as shall be deemed reasonable from time to time and for the purposes of the said matters and actions in Courts or otherwise the TRUSTEES or any of them or the MANAGING TRUSTEE shall be entitled to sign and verify all complaints, petitions, pleadings, written statements, memorandums, Vakalatnamas powers the TRUSTEES or any of them shall be entitled to appear for and on behalf of the TRUST and give evidence orally or adduce any evidence and take necessary proceedings, on the said matters and actions :
21. **THAT** a resolutions in writing circulated amongst all the TRUSTEES duly signed by them shall be valid and effective as if it has been passed at a meeting of the TRUSTEES duly called and convened:
22. **THAT** any of the TRUSTEES may retire from trusteeship if he or she so desires, but with acceptable reasons :

23. **THAT** the power to appoint / nominate new or additional TRUSTEES so as not to exceed the maximum number of TRUSTEES existing herein and to fill vacancy in the office of the TRUSTEE shall vest in the continuing TRUSTEE or TRUSTEES:
24. **THAT** on a new TRUSTEE being appointed / nominated on his signing the Minutes Book to holding the effect of his possession of the TRUST PROPERTIES shall vest in him along with the other TRUSTEES for the time being and he will be entitled or to carry out the duties and function of a TRUSTEE:
25. **THAT** for amendment or charge of any clause of this TRUST DEED the MANAGING TRUSTEE in consultation with the SETTLER shall prepare it and get in accepted the BOARD OF TRUSTEE:
26. **THAT** in case members of BOARD OF TRUSTEE decide finally in the meeting of the BOARD OF TRUSTEE that they shall not continue the TRUST any more, the clearing all the accounted liabilities fully of the TRUST from the proceeds of the assets of the TRUST, wind up THE TRUST legally, and shall handover all the residue assets of the TRUST to a similar CHARITABLE TRUST or The Government who will carry on all the works of this TRUST.
27. **THAT** in all meetings of the TRUSTEES  $\frac{3}{4}$ <sup>th</sup> of the existing TRUSTEES will form a quorum provided however, that if it the number of TRUSTEES fall below  $\frac{3}{4}$ th then for the purpose of appointing a TRUSTEE  $\frac{1}{2}$  of the existing TRUSTEE will be a quorum.
28. **THAT** the trustees shall from time to time choose one of them as Chairman of the

Board of the Trustee for such period as they think proper. The Chairman for the time being of the Board of trustees shall be Chairman of the meeting of the Trustees.

29. **THAT** the Managing Trustee shall be deemed, to be the Secretary of the Trust and he will be the only authorized signatory of the Trust for all purpose unless he nominates someone to sign on his behalf for some specific purpose.

30. The Trustees shall keep a minute book of the proceedings.
